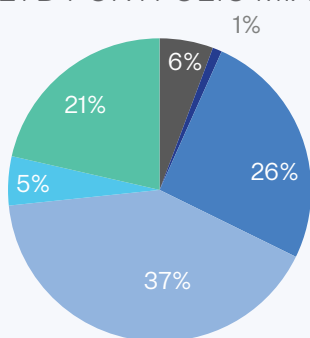

Objective

The WISC Limited Term Duration (WISC LTD) Series seeks to maintain safety of principal and limited price volatility while maximizing income through a diversified portfolio of high quality investments.

Investment Approach & Features

- Diversified, short-term, investment grade fixed income securities
- Average maturity of 0-2 years targeting one-year Series duration
- Structured to protect capital and enhance income
- Securities may include U.S. Treasuries, U.S. Agencies, Bank Certificates of Deposit, Commercial Paper, Collateralized Repurchase Agreements, U.S. Corporate Investment Grade Bonds and Municipal Bonds
- Minimum credit quality of portfolio holdings: AA or A1/P1 as applicable
- Investment purchases are compliant with Wisconsin State Statute 66.0603
- The portfolio is designed with limited duration to control price volatility
- Series reporting integrated with monthly WISC statements

Restrictions

- Must be a WISC Participant
- Minimum investment balance of at least \$100,000 in LTD Series
- 30-day advance notice required for quarterly withdrawals; funding available on predetermined dates based on calendar quarter
- An investment in the LTD Series is intended only for cash reserves not needed until 6-9 months or longer
