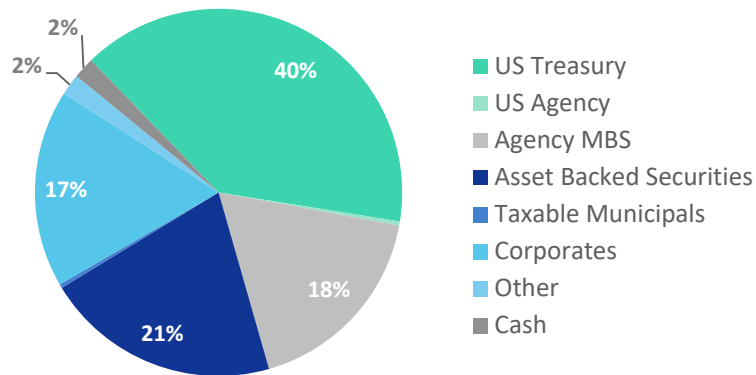

Objective

The WISC Extended Term Duration (WISC ETD) Series seeks to enhance income with potential additional return over market cycles by investing in the 1-10 year maturity range through a diversified portfolio of high quality investments.

Investment Approach

- Diversified, longer-term, investment-grade fixed income securities
- Average maturity of 3-4.5 years, targeting 4-year Series duration
- Structured to enhance income with additional return potential over market cycles
- Minimum credit quality of portfolio holdings: AA
- All investments will be compliant with Wisconsin State Statute 66.0603
- Longer duration aimed to enhance income and return, matching longer term investment horizons

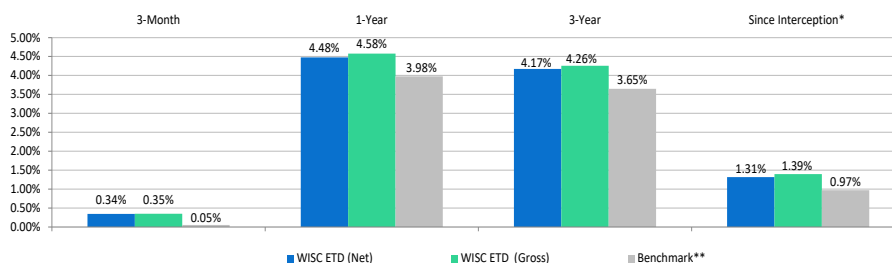
